4. Bid must be accompanied by a photocopy of current Mayors Permit, DTI or SEC Registration of the bidder.
5. The original copy of the Mayors Permit, DTI, or SEC Registration shall be presented during the bid opening for validation purposes.
6. All items for disposal are available for inspection on October 20, 2022 at 10.00 am, at Folk Arts Theater and LA Building, CCP Complex, Roxas Boulevard, Pasay City. After the inspection, a pre bid conference will follow at the Finance and Admin front lawn or at a place deem safe by the DC.

The Cultural Center of the Philippines reserves the right to accept or reject any or all bids without offering any reason, to waive any formality or technicality, to determine and to award to any bidder with the highest complying bid and whose proposal is deemed most advantageous to the CCP, provided the offer is not less than the minimum bid price. The CCP neither assumes any obligation for any loss whatsoever that may be incurred by the bidders in the preparation of their respective bids.
