SALE OF WASTE MATERIALS FROM BUILDING REHABILITATION OF CCP MAIN BUILDING ALUMINUM, G.I. SHEETS AND SCRAP METAL

 The Cultural Center of the Philippines (CCP) through its Disposal Committee (CCPDC) now invites bids for the sale of waste materials from the rehabilitation of CCP Main Building on "As is Where is and Clean Up "basis and on a per kilo basis as follows:

- 2. Bidding will be conducted through sealed bid on May 29, 2024 10:00 am at the Finance and Administration Building, CCP Complex Roxas Boulevard, Pasay City.
- 3. Bids must be delivered to the address below on or before May 29, 2024 10:00 am. Bids must be accompanied by a bid bond deposit in the form of Cash, Cashier's Check, or Manager's Check amounting to P30,000.00 deductible to the total amount of bid.
- 4. Bid must be accompanied by a photocopy of current Mayors Permit, DTI or SEC Registration of the bidder.
- 5. The original copy of the Mayors Permit, DTI, or SEC Registration shall be presented by the winning bidder prior to formal issuance of Notice of Award for validation purposes.
- 6. All items for disposal are available for inspection on May 22, 2024 at 10.00 am, at CCP Main Building Loading Dock and South Parking, CCP Annex and Folk Arts Theater, CCP Complex, Pasay City. After the inspection, a pre bid conference will follow at the Finance and Administration Building front lawn or at place deemed safe by the Disposal Committee.
- 7. The CCP reserves the right to accept or reject any or all bids without offering any reason, to waive any formality or technicality, to determine and to award to any bidder with the highest complying bid and whose proposal is deemed most advantageous to the CCP, provided the offer is not less than the minimum bid price. The CCP neither assumes any obligation for any loss whatsoever that may be incurred by the bidders in the preparation of their respective bids.

GUIDELINES ON THE DISPOSAL OF WASTE MATERIALS FROM REHABILITATION OF CCP MAIN BUILDING – ALUMINUM, G.I. SHEETS AND SCRAP METAL

To immediately clear the construction area and the limited storage space and generate income, the following policies and procedures are hereby adapted for the disposal of the following scrap/waste materials in pursuant to Sec. 79 of PD 1445 which states "When Government property has become unserviceable for any cause or is no longer needed, it shall upon application of the officer accountable therefore, be inspected by the head of the agency or his duly authorized representative and if found to be valueless or unserviceable, it may be destroyed. If found valuable, it may be sold at public auction to the highest bidder under the supervision of the proper committee on award or similar body."

1 Lot Assorted Aluminum (Ducting, Pin Light Fixture and Frames)

1 Lot Assorted G.I. Sheets (Ducting and Fluorescent Light Fixture)

1 Lot Assorted Scrap Metal (G.I. Pipes and Angle Bars)

- 1. Sealed bidding shall be advertised at CCP website and to conspicuous places.
- 2. Bids may be typewritten or hand written.
- Interested bidders may secure the bidding documents from the Property and Supply Office upon payment of a non-refundable fee in the amount of Five Hundred Pesos (Php 500.00) only.
- 4. Bids with incomplete information as required in the bidding documents and alterations made without affixing initial by the bidder shall be declared disqualified by the CCP Disposal Committee (CCPDC).
- 5. The date, time, and the designated place for the opening of bids shall be as follows:

Time

: 10:00 am

Place

: Front Lawn, Finance & Administration Building

- 6. Bidders or through their authorized representative may submit their sealed bids to the CCPDC Secretariat on or before May 29, 2024 at 10:00 am
- 7. Closing time for acceptance of bids shall be on May 29, 2024, 10:00 am at the Finance and Administration Building, CCP Complex, Roxas Boulevard, Pasay City.
- 8. The bids shall be opened at the designated place, date and time specified by the CCPDC in the presence of the COA representative and the participating bidder/representative (present/not present during the bid opening).
- 9. The bidder or his duly authorized representative must be able to submit to the DC a written proof of authorization to bid, re-bid and withdraw from bidding.
- 10. If there are similar bid amounts, the concerned bidders shall be required to revise, seal and submit their bids and corresponding increase in the bid bond to the DC on the same hour of the bidding. Bidders/representative who choose not to attend the bid opening will loose the opportunity to submit a revised bid. The DC shall open and declare the revised bids upon submission.



- 11. Should the winning bidder fail to comply with the required payment within five (5) working days after the receipt of Notice of Award (NOA), the bid shall be awarded to the second highest bidder. In case where there are no bidders left, a re-bidding shall then be held at a time and place to be announced by the committee.
- 12. In case of failure of sealed bidding for two (2) times, the CCPDC may dispose the same through negotiation
- 13. In case of failure to fully pay the contract amount within the deadline as set by the CCPDC, the winning bidder/s shall be penalized through a cancellation of the award, forfeiture of the bid bond in favor of CCP and inclusion on the list of blacklisted bidder for a period of one (1) year from the date of the notice of award.
- 14. By joining the aforesaid bidding, the bidders hereby acknowledged that he/she fully understand and agreed to the guideline set forth in the Invitation to Bid and to the above enumerated guidelines on the disposal of CCP's waste materials from the rehabilitation of CCP Main Building.
