The CULTURAL CENTER OF THE PHILIPPINES, hereinmer referred to as the CCP, a government-owned-and-controlled corporation, created by virtue of Presidential Decree 15, as amended, with principal address at Roxas Boulevilld, Pasay City, represented herein by its President, ARSENIO J. LIZASO, duly authorized for the purpose of this Contract, copy of which is hereto attached as Annex "A";

and

I-ASIATIC INNOVATIONS PHILS., INC. hereinafter referred to as CONTRACTOR, a private corporation organized and existing under Philippe Faws, with office address at 11/F Cyber One Building Eastwood Cyberpark City Bagumbayan, Quezon City, represented herein by its President, SHERY ANNE SOU, duly authorized for the purpose of this Contract, copy of which is hereto attached a Annex "B".

(Collectively referred to as the Parties

WITNESSETH: That

WHEREAS, the CCP Bids and Awards Committee (CCP BAC) published on August 18, 2017 in the Government Electronic Procurement System (PhilGEPS) as mandated by R.A. 9184, and in the CCP Website, the Invitation to Bid for certain goods and ancilla services, viz., Procurement of the Design, Development and Installation of CCP Encyclopedia a Philippine Art Applications in Web, Mobile and Interactive Multi-Touch Panels with an ABC of Fi Million Pesos (Php 5,000,000.00), inclusive of VAT:

WHEREAS, on September 22, 2017, the CCP BAC deckned a failure of bidding because there were no bids received in time;

WHEREAS, the CCP BAC republished the Invitation to Lat, but the bidding failed anew after the bidder was disqualified;

WHEREAS, after the two failed biddings, the CCP BAL resorted to negotiated procurement which was again published in the PhilGEPS and CCP websites. B. CCP BAC then declared, for the third time, a failure of bidding on anuary 5, 2018;

WHEREAS, on February 15, 2019, the CCP BAC processed with the posting in the PhilGEPS and in the CCP Website the Notice for Negotiated Procurement Two (2) Failed Biddings, for the same project;

WHEREAS, after the post-evaluation of the submitted B. Documents by the Technical Working Group and the CCP BAC, the proposal of the CONTRACTOR to been found to be the responsive bid and is deemed acceptable and advantageous to the CCP;

WHEREAS, the CCP BAC in its Resolution No. 2019-12 hated May 29, 2019 has recommended to award the contract for the Procurement of the Design, Development and Installation of CCP Encyclopedia of Philippine Art Applications in Web, Mobile and Interactive Multi-Touch Panels to the CONTRACTOR which was approved by the President or the ultural Center of the Philippines;

WHEREAS, a Notice of Award dated May 31, 2019 we assued to the CONTRACTOR for the Procurement of the Design, Development and Installation of GCP Encyclopedia of Philippine Art Applications in Web, Mobile and Interactive Multi-Touch Panels to be delivered within six (6) months after the issuance of the Notice to Proceed for the total Contract Price of Four Million Four Hundred Ninety Nine Thousand Nine Hundred Ninety Nine Pesos (PHP 499,999.00), inclusive of VAT.

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree and covenant as follows:

- 1. In this Contract words and expressions shall have the same meanings as are respectively assigned to them in the General Conditions of Contract (GCC) and in the Special Conditions of the Contract (SCC) hereto attached;
- 2. The following documents shall be made integral part of the Contract, as fully as if the contents of the said documents are reproduced, incorporated and set forth herein, and shall govern and control in full force and effect the rights and obligations of the parties, except as otherwise modified by the terms and conditions of the Contract, or by mutual agreement of both Parties in writing, and by the provisions of relevant laws, codes, ordinances, rules and regulations of the government:
 - a. Conditions of the Contract (General and Special),
 - b. Invitation to Apply and Eligibility to Bid (IAEB);
 - c. Eligibility requirements, documents, and/or statements;
 - d. Performance Security;
 - e. Entity's Notice of Award dated May 31, 2019 and waning bidder's "Conforme";
 - f. BAC Resolution No. 2019-12 dated May 29, 2019
 - g. Post-Qualification Documents submitted by the Bidder;
 - h. Supplier's Bid, including the Technical and Financial Proposals, and all other documents/ statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
 - i. Bid Documents pages 1-94; and
 - j. Terms of Reference; and
 - k. Bid Bulletin

- 3. In consideration of the payments to be made by the CCP to the CONTRACTOR, the CONTRACTOR hereby agrees with the CCP to provide the goods and services and to remedy defects therein to conform in all respects with the provisions of the Contract. In particular, the CONTRACTOR shall deliver at the Cultural Center of the chilippines, Roxas Boulevard, Pasay City, not later than six (6) months upon issuance of the Notice to Proceed, the CCP Encyclopedia of Philippine Art Applications, including the source code to the following platforms:
 - a. Website
 - b. Mobile App for Android and iOS
 - c. Digital Interactive Multi-Touch Panels
- 4. The CONTRACTOR should also provide trainings and tutorial sessions on how to update and upload additional content to all the platforms so that CCP conclustomize and update the website, mobile app and the digital installation regularly. All entries articles and audio-visual materials, design and user interface of the website, mobile app and interactive touch panels are owned by the CCP.
- 5. The CONTRACTOR shall pay a penalty of PHP 600.00 each day of delay which shall be deducted from the remaining balance in addition to the liquid and damages as provided for under Section 19 of the General Conditions of the Contract (GCC).
- 6. CCP hereby covenants to pay the CONTRACTOR in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price of Four Million Four Hundred Ninety Nine Thousand Nine Hundred Ninety Nine Pesos (PHP 4,499,999.00), inclusive of VAT, payable under the provisions of this Contract in the following manner:
 - Upon completion of design and development of EPA website, EPA mobile app and EPA digital installation software – 35%
 - Upon completion of uploading of content of the EPA website, EPA mobile app and EPA digital installation and upon delivery and set-up of the multi-touch panels of the EPA digital installation – 35%
 - c. Upon completion of turnover, upload turorial and a lamission of source code for all platforms 30%

7. Intellectual property rights of the soft copy of the Encyclopedia of Philippine Art is owned by the CCP. Uploading, replicating, and other means of reproduct a and distribution of the materials, such as, but not limited to, articles, photos and volumes whereat CCP's written consent is strictly prohibited. Should the CONTRACTOR be found guilty of violating this agreement, the CONTRACTOR shall be held liable and punishable under the Philippine law.

- 8. The CONTRACTOR warrants one (1) year for content assion and one (1) year for digital installation equipment. The CONTRACTOR shall provide at contraction upon delivery.
- The CONTRACTOR agrees to pay taxes in full and on time and that failure to do so will entitle the CCP to suspend payment for any goods or services delivered by it. Moreover, the CONTRACTOR shall regularly present, within the duration of the contract, a tax clearance from the Bureau of Internal Revenue as well as copy of its income and business tax returns duly stamped and received by the Bureau of Internal Revenue and duly validated with the tax payments made thereon.
- 10. In case of suit arising out of this agreement, the exclusive verses shall be the court in Pasay City.
