RECOMMENDATION OF AWARD

CP-30 - SUPPLY, DELIVERY, INSTALLATION, TESTING, AND COMMISSIONING OF ACCESSIBILITY AND WHEELCHAIR PLATFORM LIFTS FOR THE CCP TANGHALANG AURELIO TOLENTINO ENTRANCE (TAT), TANGHALANG NICANOR ABELARDO (TNA), AND BULWAGANG FRANCISCA REYES-AQUINO (BULFRA)

WHEREAS, the End-user, Production and Exhibition Department (PED) submitted a request to procure Supply, Delivery, Installation, Testing, and Commissioning of Accessibility and Wheelchair Platform Lifts for the CCP Tanghalang Aurelio Tolentino Entrance (TAT), Tanghalang Nicanor Abelardo (TNA), and Bulwagang Francisca Reyes-Aquino (BULFRA);

WHEREAS, there are funds available and allotted for this purpose as evidenced by the inclusion of the project in the Cultural Center of the Philippines (CCP) Annual Procurement Plan;

WHEREAS, in accordance with Section 49 of the Implementing Rules and Regulations (IRR) of Republic Act No. 12009 (New Government Procurement Act), the CCP, through its Bids and Awards Committee (CCP-BAC), conducted the required Pre-Procurement Conference on 03 April 2025;

WHEREAS, in accordance with Section 50 of the IRR of R.A. No. 12009, the Invitation to Bid for the project was published on 08 June 2025, with an Approved Budget for the Contract (ABC) of **Six Million Two Hundred Fifty-Five Thousand Pesos (Php6,255,000.00)** inclusive of VAT and other applicable government taxes;

WHEREAS, in accordance with Section 41 of the IRR of RA12009, a Pre-Bid Conference was held on 17 June 2025 and was attended by the following prospective bidder/s:

1. Elevating Specialist Philippines, Inc.

WHEREAS, on 24 June 2025, the CCP-BAC issued Bid Bulletin no. 1 to amend provisions in the bidding documents for the aforementioned project;

WHEREAS, during the bid opening held on 01 July 2025, **no bids were received** from this project;

WHEREAS, in view of the absence of any bid submissions, the CCP-BAC declared a **failure of bidding** pursuant to Section 64 of the IRR of R.A. No. 12009;

WHEREAS, in view of the failure of the first competitive bidding, the CCP-BAC endorsed the review and adjustment of the approved budget for the contract (ABC), resulting in a new Approved Budget for the Contract in the amount of **Fourteen Million Two Hundred Thirteen Thousand Five Hundred Forty-Five and 07/100 Pesos (Php14,213,545.04)**, which was duly approved by the CCP Board of Trustees;

WHEREAS, the Invitation to Bid for the aforementioned project was re-published on 04 July 2025, reflecting the revised ABC;



WHEREAS, a pre-bid conference was held on 11 July 2025 and was attended by the following prospective bidder/s:

1. Elevatoring Specialist Philippines, Inc.

WHEREAS, in response to said posting, the following prospective-bidders purchased the bidding documents:

1. Elevatoring Specialist Philippines, Inc.

WHEREAS, during the opening of bids on 31 July 2025, one (1) bidder submitted a bid before the deadline, namely:

1. Elevatoring Specialist Philippines, Inc.

WHEREAS, during preliminary examination of bids, the CCP-BAC found that the bidder submitted an outdated Annex "A" of the PhilGEPS Registration (Platinum Membership);

WHEREAS, in view of the foregoing, the CCP-BAC declared the lone bidder ineligible, resulting in a failure of bidding pursuant to Section 64.1 of the IRR of R.A No. 12009;

WHEREAS, the Invitation to Bid for the re-bidding of the project was duly published on 13 August 2025;

WHEREAS, a pre-bid conference was held on 20 August 2025 and was attended by the following prospective bidder/s:

1. Elevatoring Specialist Philippines, Inc.

WHEREAS, in response to said re-bidding, the following prospective bidders purchased the bidding documents:

1. Elevatoring Specialist Philippines, Inc.

WHEREAS, during the opening of bids on 02 September 2025, Elevatoring Specialist Philippines, Inc was found "eligible/compliant with the eligibility requirements;

WHEREAS, during the opening of Envelope No. 2: Financial Proposal, the bid offer was as follows:

WHEREAS, upon detailed evaluation of bids (*Annex "A"*), the result are as follows:

WHEREAS, a notice of post qualification was issued to the Single Calculated Bid (SCB) on 5 September 2025 (*Annex "B"*);

WHEREAS, the post-qualification and technical evaluation confirms that Elevatoring Specialist Philippines, Inc. was found compliant and responsive, as well to be technically, financially and legally capable to execute the works of **ITB No. 25-013-RB Supply, Delivery, Installation, Testing, and Commissioning of Accessibility and Wheelchair Platform Lifts for the CCP Tanghalang Aurelio Tolentino (TAT) Entrance, Tanghalang Nicanor Abelardo (TNA), and Bulwagang Francisca Reyes-Aquino (BULFRA)** with a bid amount of Seven Million Seven Hundred Seventy-One Thousand Seven Hundred Thirty-Seven and 04/100 Pesos (Php7,771,737.04);

NOW, THEREFORE, We, the Members of the CCP Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare **Elevatoring Specialist Philippines, Inc.** as the Single Calculated Responsive Bid (SCRB) for the procurement of **Supply, Delivery, Installation, Testing, and Commissioning of Accessibility and Wheelchair Platform Lifts for the CCP Tanghalang Aurelio Tolentino (TAT) Entrance, Tanghalang Nicanor Abelardo (TNA), and Bulwagang Francisca Reyes-Aquino (BULFRA)** with a contract amount of **Seven Million Seven Hundred Seventy-One Thousand Seven Hundred Thirty-Seven and 04/100 Pesos (Php7,771,737.04)**;
- b. To recommend for approval of the CCP Board of Trustees as the Head of the Procuring Entity the award of the contract to Elevatoring Specialist Philippines, Inc.




