Dear Trustees,

- a. Is an annual performance assessment conducted of the Board of Directors Committees?

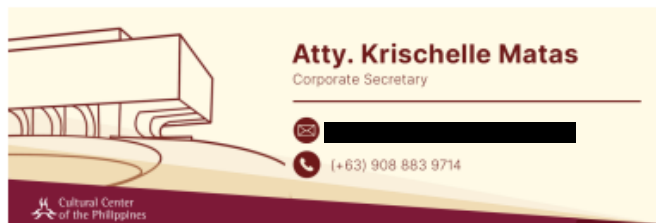
